1. Responsibility for Conduct

I accept and acknowledge full liability for any loss, damage, injury, or inconvenience caused by my pet to Hotel, individuals, or other pets within the Hotel premises.

I indemnify and hold harmless IHCL and the Hotel from all claims, losses, or damages arising due to my pet.

2. Compliance with Hotel Policies

I agree to abide by the Hotel's pet policy (Attached), including

- Restrictions on pet access to specific areas such as restaurants, bars, banquet spaces, swimming pools, and fitness areas.
- pet shall remain leashed in public areas and will not be left unattended in the room.
- Cover all medical expenses, loss, costs and / or damages incurred by others due to my Pet(s).

- Meet any additional charges associated with the accommodation of my Pet(s).

3. Damages and Cleaning

I agree to cover all costs related to damages or deep cleaning if required. A refundable cleaning and damage deposit will be collected upon check-in, which will become non-refundable if damages or extra cleaning are required.

4. Health and Vaccination

I confirm that my pet is vaccinated, free from ticks and infections, and will not pose a health hazard. A copy of the vaccination card will be provided upon request.

5. Behavioural Responsibility

I acknowledge that excessive barking or disturbances caused by my pet may result in the Hotel requesting our immediate departure. I will not contest such a decision.

6. Waiver of Liability

I understand that the Hotel does not assume responsibility for any injury, illness, or loss of life involving my pet. Any assistance offered by Hotel staff is voluntary and does not imply liability.

In emergencies, the Hotel may contact a local veterinarian at my expense but assumes no responsibility for outcomes.

7. Additional Charges

I agree to pay all applicable charges related to the accommodation of my pet as outlined by the Hotel's standard terms.

9. Owner's Presence

I will ensure my presence in the room during housekeeping or in-room dining services and provide notice for the same.

10. Waste Management
